Terms and conditions

1 Your Contract

- “mylifesavour” means Luvit Ventures Company Limited
- “Website” means www.mylifesavour.com

The Terms and Conditions set out below apply to the provision to you by mylifesavour of the mylifesavour card and are to be read in conjunction with the terms and conditions appearing from time to time on the Website. Please read these Terms and Conditions carefully before entering into the contract and buying the mylifesavour card. By completing either the online or hard copy application form for a mylifesavour card you are agreeing to be bound by these Terms and Conditions. mylifesavour reserves the right to amend these Terms and Conditions at any time by giving you notice by posting the amended terms and conditions on the Website.

2 Minimum Age

The mylifesavour card is only available to adults 18 years old or over.

3 Term and Renewal

Your Mylifesavour card is valid for 12 months from the date of purchase (unless otherwise stated). The expiry date will be printed on the card and you will receive a communication from mylifesavour within a month of the expiry date advising you how to renew your card.

4 Availability and delivery

You will receive a welcome email. A personalised card will be sent to you in the post and will arrive within 7 working days of your purchase (working days are Monday to Friday, excluding public holidays), unless you are otherwise advised. If a card is required to be reissued as a result of the cardholder providing the incorrect details at the time of purchase, a replacement fee of \$15 will be charged to the cardholder.

5 Price and payment

The price of the mylifesavour card will be as quoted on the Website from time to time, except in cases of obvious error. Prices are liable to change at any time, but any changes will not affect orders in respect of which we have already sent you confirmation. The cost for a replacement card should you require one will be \$15, which covers our handling and production costs. Payment can be made by visa or mastercard or via bank transfer or other methods we may agree, as detailed on the Website.

6 mylifesavour Card Partners

On presentation of the mylifesavour card, participating mylifesavour partner restaurants and bars will offer up to 50% off your total bill, food bill only or drinks bill only. This will apply to everyone in your group, although the participating restaurant may impose a limit, which is normally eight persons per card unless otherwise stated. Please check the terms and conditions of the offer you are interested in, which will confirm these details. Certain days may be excluded from the offer. Please check the terms and conditions of the particular offer you are interested in on the Website for further details. Some participating mylifesavour card partner restaurants may require you to pre-book and therefore you should state at the time of booking that you intend to use the mylifesavour card. mylifesavour shall use all reasonable efforts to keep the Website updated with particulars of participating restaurants and their terms of availability under the mylifesavour card scheme.

Offers advertised on the Website are not available in conjunction with any other offers the participating mylifesavour partner may be running. The expiry date of your mylifesavour card will be checked by the participating mylifesavour card partner when you redeem the offer. Expired mylifesavour cards will not be accepted. The mylifesavour card is strictly non-transferable so cannot be used by either friends or family members. Any attempted misuse of the mylifesavour card will result in cancellation of the card. We will use reasonable endeavours to ensure the Website is kept up to date to show a full portfolio of discounts and benefits available. mylifesavour card partner restaurants and bars may, however, be entitled to withdraw their offer, or change the terms and conditions of their offer after you have subscribed to the mylifesavour card. mylifesavour shall have no liability for any such withdrawals or changes in the Terms and Conditions. Cardholders will have the benefit of any additional participating mylifesavour card partner restaurants and bars who join the mylifesavour card Scheme at a later date.

7 Liability

Our liability to you if we fail to comply with these Terms and Conditions, is limited to the annual fee for the mylifesavour card. mylifesavour will not be responsible for any indirect losses, consequential, exemplary, special or punitive damages, lost opportunities, loss of profits, anticipated profits, actual or anticipated savings even if mylifesavour has been advised of the possibility of such damages. We do not limit our liability at law for fraudulent misrepresentation or for death or personal injury caused by negligence or any other type of liability which cannot by law be excluded or limited. We do not accept liability for unsatisfactory experiences or any failure by our Partners to deliver expected services and quality. Any complaints should in the first instance be taken up directly with the relevant mylifesavour Card Partner and thereafter mylifesavour will endeavour to investigate any unresolved problems.

You agree to hold us harmless against all losses, liabilities, claims or demands arising out of any breaches of the representation and warranties and assurances. mylifesavour reserve the right to vary, amend or cancel this promotion at any time and you agree that no liability shall attach to us as a result thereof. mylifesavour do not accept any liability in the event that a mylifesavour Card Partner withdraws from the mylifesavour card scheme or changes its terms and conditions of availability after you have become a member.

Any person who is not a party to these Terms and Conditions shall have no rights to enforce any term of these Terms and Conditions.

12 Entire agreement

These Terms and Conditions and an document expressly referred to, and any specially agreed terms constitute the entire agreement between the parties in connection to, its subject matter and supersede any previous terms and conditions, agreement or arrangement between the parties.

Each of the parties agrees that it has not entered into these Terms and Conditions in reliance on, and shall have no remedy in respect of, any statement, representation, covenant, warranty, undertaking or indemnity (whether negligently or innocently made) by any person (whether party to these Terms of Conditions or not) other than as expressly set out in these Terms and Conditions.

13 Use of Personal Data and Data Protection

mylifesavour may use all the information that you supply to us in purchasing the mylifesavour card (such as your name, address, email address, telephone number etc) for the purposes of:

- administering the scheme;
- statistical analysis;
- sending you news of our special events, offers, promotions and newsletters either by post, email, SMS or through any social network; and
- market research.

14 Governing Law and Jurisdiction

These Terms and Conditions shall be governed by and construed in all respects in accordance with the Republic of the Union of Myanmar Law and the parties agree to submit to the exclusive jurisdiction of the Republic of the Union of Myanmar courts.
